### **Program Improvements**

The Department of Graduate Counseling (DOGC) evaluated each outcome for 2016-2017 and identified programmatic improvements for 2017-2018. The following is a description of improvements that will be a focus of the DOGC in 2017-2018.:

- In 2017-2018 a new assessment procedure will be implemented for the Graduate Counseling program. Grace College has hired an Assistant Provost to oversee assessment institutionally and he is partnering with a consultant to improve and enhance assessment for all departments in the college.
- In 2017-2018 program goals will be revised to better assess program outcomes.
- Seven of the sixteen program goals were achieved based on all methods of assessment. Nine of the sixteen goals were partially achieved. This was due to raising goal standards. In 2016-2017 goal standards were raised from achieving an average score of 3.0 to achieving an average score of 4.0 on Exit, Employer, and Alumni surveys. Goals were raised to reflect the program's mission and biblical call to strive for excellence in educating counselors. While progress was made towards meeting these higher goals, several goals were only partially achieved. The DOGC faculty will meet in early Fall 2017 to develop a plan for consistency in reaching standards of excellence across all program goals.
- In 2016-2017 the DOGC piloted new, more rigorous cutoff scores for passing the CPCE exit exam. Cutoff scores were raised from 1 standard deviation below the national mean score to .5 standard deviation below the national mean score to reflect the program's mission and biblical call to strive for excellence in educating counselors.. Almost all of the students were able to meet the higher cutoff scores; therefore, the DOGC will continue to set the cutoff scores at .5 standard deviation below the national mean for 2017-2018 academic year.
- Exit Survey scores of recent program graduates were, by and large, significantly lower than Employer Survey scores of alumni practicing in the field. This may be due to students' lack of feelings of self-efficacy. The DOGC will evaluate whether a plan for improving student self-efficacy should be developed.
- In order to improve outcomes for faith-related criterion, the DOGC will consider methods for increasing faith integration and application of biblical principles in all courses.
- In order to address content areas of the CPCE that had lower pass rates by students taking the exit exam, faculty assignments have been adjusted to ensure that faculty are

- teaching courses that they are passionate about, have solid experience with, and feel confident teaching. Faculty have been provided with the CACREP standards for each course as well as texts created as study guides for students taking the CPCE so that they are familiar with the content that is assessed by the CPCE.
- For 2017-2018 Master Course Managers (MCM) have been assigned for each course to ensure that all courses taught by core faculty and part-time faculty are aligned and are meeting CACREP standards, are delivering content assessed on the CPCE exit exam, and are staying current with course materials and assignments that reflect the student population and current trends in the counseling profession. (Master Course Managers are core faculty who are assigned to specific Moodle courses and are responsible for developing, editing, and revising content, curriculum, resources, and assignments for that specific course. Master courses are then used to create all sections of a course every time it is offered).
