- Practicum: Six semester or nine quarter units of supervised practicum or field study experience, including, but not limited to, a minimum of 280 hours of face-to-face supervised clinical experience counseling individuals, families, or groups. (Grace meets this requirement)
- 12-hour course in California law and professional ethics. The coursework may be from an accredited or approved school, college, or university, or from a continuing education provider that is acceptable to the board. Undergraduate coursework shall not satisfy this requirement. An applicant shall complete this coursework before registration as an associate. (Must take this in CA)
- License applicants will be required to take additional coursework required by California, outside their degree requirements— up to 12 semester hours can be remediated while in the associate licensure process (take missing courses in CA)



## **Licensed Marriage and Family Therapist (LMFT)**

Some CA students in the past have chosen to pursue a Licensed Marriage and Family Therapy license. The LMFT requirements now outline 15 credit hours required in marriage and family and/or systems approach. Grace College has one marriage and family course (3 credit hours).
